# EDITORIAL CONTD.

#### Press Statement from the Prison Officers' Association, 18 Sep 14

The Prison Officers' Association can confirm that industrial action, in the form of a work stoppage went ahead at Cloverhill Prison today and a further one hour stoppage is planned for tomorrow.

Jim Mitchell, Deputy General Secretary, POA, said this evening,"We are bitterly disappointed that talks at the Labour Relations Commission on Tuesday last, which could have resolved this industrial action at Cloverhill, were unnecessarily delayed. Today's industrial action has gone ahead primarily because of a lack of staff on the landings in Cloverhill - and the knock on safety issues, which have developed. Prison Officers at Cloverhill are understandably concerned about the types of prisoners being housed there and the increased risk associated with this".

Mitchell went on to say, "There is a lack of application of Health and Safety measures at Cloverhill - and this is a direct responsibility of prison management. It is most regretful that management could not have made a more constructive effort to resolve the very real safety issues for our members at Cloverhill and in doing so could have avoided today's industrial action".

The industrial action at Cloverhill Prison will also proceed tomorrow (Friday) from 2pm to 3pm, as will the industrial action planned for next week at Mountjoy Prison. This is the current position unless management can find a way of addressing the key safety issues, which have been clearly identified.
















# John Allman R.I.P.

It was with great sadness that we learned of the passing of our colleague and friend John Allman. The suddenness of his passing had everyone in shock. John was a character in the Irish Prison Service and was larger than life with all his stories of his exploits with his comrades and would repeat these stories to anyone who would listen. In reality John was like a rolo; hard on the outside and soft on the inside. John would do you no harm and would always be first in line to help you out if you had a problem.

John loved his family and spoke passionately about his brothers, sisters, daughters and grandchildren to his close friends. On visiting John in hospital we couldn't get over his courage and bravery in the face of the heavy news that his illness was terminal. John would say "Ah, horse, I can't turn the clock back; I will just have to deal with the hand I'm dealt." John was so excited about his family and especially his daughters coming up to visit him while in hospital. He was like a child waiting for Santa to come. He was beaming after that visit.

John will be sadly missed by his entire family, the Irish Prison Service and all the friends that he made over his near 30 years service; especially his closest, and best friends of which he had so many. John will also be greatly missed by Elsie, who was his long term partner. John's other passion was fishing. He loved to be out in the open air. The stories he told about his fishing trips you would think he was after catching the Lough Ness monster - the fish were getting bigger every time he told the stories but John was an excellent fisher man.

John made a great and lasting impression on everyone he met. John was "John."

"Horse" was John's catchphrase; and he used it a lot; everyone was "Horse" to John. Even the prisoners of Arbour Hill were shocked at John's sudden passing. One prisoner had said that he was "...such a good man. He would always look after you. Mr. Allman will be missed. He was great craic. He was a gentleman and we will miss all of his stories."

We were all privileged to know John Allman; and to his family we extend our deepest sympathies. We will miss every aspect of John - his stories, his company, his friendship and his great wit and tremendous sense of humour that he kept with him to the very end. But most importantly, we will miss the Giant that was John.




