

EDITORIAL

Colleagues,

Welcome to the Spring 2019 edition of the Prison Officer Newsletter. As you may be aware there is a new General appointed Director to the Irish Prison Service. Ms Caron McCaffrey has been appointed to the role and we look forward to working with the new D/G in the future. Our initial engagement with Ms McCaffrey on the 26th February 2019 was constructive where we raised the issues of the Implementation of the Revised Civil Service Disciplinary Code into the Prison Service, an update on the National Review of P19s, a commitment to previous Agreements, the reopening of the Training Unit, the National Flow Plan, Campus Structure Proposals, Matters relating to the Dochas Centre and the use of body warn cameras.

Pay

The remaining Pay and Pension Provision measures provided for under the terms of the Public Service Stability Agreement 2018 – 2020 are as follows:

- 1st September 2019: 1.75% pay adjustment
- 1st January 2020: The Pension levy threshold will move up to €34,500. This is worth €250 per annum. The measures is for non-fast accrual grades and grades that are in the new Single Public Service Pension Scheme.

 1st October 2020: 2% pay adjustment.

There was a meeting held on Friday February 2019 at 25th FORSA Headquarters between the Officer Board of the ICTU Public Services Committee and the Prison Officers Association. This meeting was part of a consultation process between the Officer Board of the ICTU Public Services Committee and affiliated Trade Unions to discuss the implications of LCR21901 relating to the Nurses dispute for Trade Unions affiliated to the ICTU Public Services Committee.

The Union raised a number of issues with the Officer Board of the Public Services Committee including getting a similar review to that taking place in the nursing area, ongoing attacks on fast accrual pension terms in the Trades and Nursing areas, Prison Nurse pay issues, Incremental Scales and matters relating to the Public Service Single Pension Scheme. The Officer Board of the ICTU Public Services Committee informed the Union that there would be further discussions with affiliated Trade Unions when the terms of the new Nursing contracts to be negotiated under LCR21901 are known.

Bank Holiday Payments: There have been a number of queries received at POA Headquarters arising from the



fact that Saint Patricks Day this year falls on a Sunday. When this situation arises the Sunday allowance will not be paid. As Sunday 17th March 2019, is a Bank/Public holiday, Staff rostered to work that day will be paid a Public holiday allowance. The Prison Service has never paid two allowances for the one day, the higher allowance was always the one paid. In the case of five-day liability staff, Monday 18th March should be granted as Public Holiday in lieu of the Public Holiday falling on Sunday 17th March.

National Officers Branch Meetings Nationwide

Continuing the practice of the four full time national officers visiting every branch to give an update on current events and ongoing issues, meetings were held in all branches between the 30th of January and the 12th of February. All branches were circularised prior to the meetings to forward any specific issues that they wished to raise with the national officers which were then discussed on the day of the meeting. The issues covered in every prison were Pay and Pensions, Provisions for Bank Holiday working, National Violence Reduction Unit, Competitions and Recruitment, Transfer Policy, Prison Admin Grades,

Code of Discipline, OID Claim, Night Duties and Staff Canteens.

Revised Civil Service Disciplinary Code

It was reported at the February NEC meeting that the POA had raised concerns with the Staff Side Secretary General Council relating to the implementation of the Revised Civil Service Disciplinary Code into the Prison Service for the purpose of having these matters raised at point 2 of the Agenda at the January General Council meeting. There was a copy of a response from the Official Side to these matters issued in the March executive file which outlined:

Disciplinary Code Claim: DPER are currently liaising with the Attorney General's Office with a view to addressing three different conflicting pieces of legislation to allow for the introduction of the Revised Civil Service Disciplinary Code into the Irish Prison Service. The POA has been advised that the current likely timeframe for implementation is end 2019.

Staff Recognition

At the time of this newsletter going to print, site visits to all locations will have been completed. The Staff Recognition Policy has been agreed and will be available for viewing on the IPS website. The cornerstone of this policy is the establishing of a Local Staff Recognition Committee. It is also important to stress that any member of staff can nominate their peers for recognition, it does not have to be left to the manager to nominate someone.

Irish Kidney Association Organ Donor Awareness Week 2019 (30 March-6 April)

The POA are delighted to help raise awareness of this very important by the initiative Irish Kidney Association. A donor has helped one of our own Simon Walshe who retired from his job as a prison officer two years ago after 30 years' service and this year is celebrating the longevity of the successful kidney transplant which he underwent 25 years ago, in February 1994. Prior to his life saving kidney transplant he had been undergoing haemodialysis treatment at Beaumont Hospital three times a week for close to two years. Simon worked at Loughan House Prison, St Patricks and Mountjoy.

In wishing to honour his deceased organ donor he was the instigator of two initiatives between the prison service and the Irish Kidney Association (IKA). One was an approach to approach the then Governor of Mountjoy Prison, John Lonergan with an idea which resulted in prisoners making benches and landscaping a garden at the IKA Renal Support Centre located on the grounds of Beaumont Hospital. In 1992 he also suggested the introduction of a Prison Officers pay deduction scheme for the Irish Kidney Association which then began and has raised over €200,000 for the charity. He is not sure of the exact amount which was raised over two decades and if the scheme is still running since he retired. Simon is also a former Chairperson on the Dublin North branch of the Irish Kidney Association.

PAY UPDATE

The Pay and Pension levy adjustments contained in the Public Service Stability Agreement 2018 – 2020 are as follows:

- 1st January 2018: 1% pay adjustment
 1st October 2018: 1% pay adjustment
 1st January 2019: Pension levy threshold up from €28,750 to €32,000 (worth €325pa). This is for non-fast accrual grades and all grades in the new Single Public Service Pension Scheme
 1st January 2019: Pension Contribution will cease on non-pensionable pay for example additional hours and overtime payments
- 1st January 2019: 1% pay adjustment for those earning less than €30,000

The remaining measures are as follows:

- **1st September 2019:** 1.75% pay adjustment
- 1st January 2020: Pension levy threshold increased to €34,500 (worth €250pa) for non-fast accrual grades and all grades in the new Single Public Service Pension Scheme
- **1st October 2020:** 2% pay adjustment.

Overview of Staff Recognition Policy

The Irish Prison Service Staff Recognition Policy is broken into 3 distinct categories.

1. Long Service Awards (Prison based service only)

Long Service Awards are by their title designed to recognise specific milestones in the service of a Prison based staff member and mark the significant contribution that the staff member has made to Irish society through the service they have provided.

A Long Service Award may be made to a staff member who possesses the qualifying service for the Award.

Under this policy the following awards will be presented on reaching the qualifying service or retirement from the Prison Service:

- 1.1.1 The Irish Prison Service Medal for Twenty-One Service
- 1.1.2 The Irish Prison Service Medal for 30 Years' Service
- 1.1.3 The Irish Prison Service Medal for Forty Years' Service
- 1.1.4 Citation of Service on Retirement

2. Recognition on Retirement

Under this Policy all retirements from the Irish Prison Service will be officially marked, subject to the agreement of the retiring staff member, to formally recognize the service given over the course of their career. Staff may choose to have their retirement marked privately.

3. Merit Awards

Merit Awards recognise acts of bravery, outstanding heroism or merit which have been performed by staff of the Irish Prison Service.

Awards will recognise an exceptional act that was beyond the normal expectation of the member of staff and taking account of their experience and training.

The awarding of Merit Awards is determined by the Staff Recognition Committee who take cognisance of the recommendation of the local Governor or management team.

All Merit Awards will be presented to officers at a formal ceremony to be held annually in their prison and at which the Director General will be present. All staff members receiving a Merit Award may invite their immediate family to attend the ceremony.

The decision to accept a Merit Award rests with the individual staff member and they have the right to refuse an Award if they so choose. In addition staff may choose to receive their Award in private.

There are three levels of award, depending on the degree of bravery, heroism or merit. The Award will consist of a medal and ribbon with a clip and/or a certificate containing a short citation of the deed involved and the category of the award. The Awards are as follows:

The Stack Medal

The Stack Medal was introduced in June 2013 and is the highest honour than can be bestowed upon a member of staff of the Irish Prison Service. The Stack Medal is presented to a staff member by the serving Minister for Justice and Equality and is recognition of an act of exceptional personal bravery by the nominee.

The Distinguished Service Medal

The Distinguished Service Medal was introduced in June 2013 is an award which can be bestowed upon a member of staff of the Irish Prison Service by the Director General and may be awarded for the following actions:

- I. Prevention of an attempted escape;
- II. An action that preserved life or prevented serious harm to others;
- III. Acts that displayed exceptional commitment under duress e.g. riots, volatile situations;
- IV. Other such significant events that the committee deems appropriate for consideration.

Special Commendations

The certificate of Special Commendation was introduced in June 2013 and may be issued where the Staff Recognition Committee consider that a particular deed of a staff member merits official recognition. The Certificate of Commendation is presented by the Governor of the Prison.

4. Excellence and Innovation Awards

Excellence and Innovation Awards recognise actions by staff, including Headquarters staff (as individuals or as part of a project team) to introduce new initiatives for the benefit of the Service. These awards are designed to reward creativity, ingenuity that has been proven to aid the management of the Service, the management of prisons or the management of offenders. Matters relating to Excellence and Innovation Awards cannot cross over, compromise, undermine or interfere in any way with the normal industrial relations or collective bargaining procedures that exist within the Irish Prison Service.

Excellence and Innovation Awards are also an attempt to acknowledge individual achievement both within and external to their work environment which brings honour to the job and to the Service. These Awards can also acknowledge excellence and professionalism of staff in the conduct of their duty while also acknowledging their excellence in service to the community.

The Excellence and Innovation Awards will be introduced with effect from 1 January 2019.

The NEC held on the 6th February was informed that site visits would take place to outline the policy to the Local Management and Local POA Branch Committees. The site visits took place as follows:

- 11 February: Mountjoy/Dochas/Arbour Hill
- 19 February: Portlaoise
- 25 February: Castlerea/Loughan House
- 27 February: Shelton Abbey
- 8 March: Midlands
- 12 March: Cloverhill/Cloverhill/Wheatfield
- 22 March: BSD/OSG
- 25 March: Cork/Limerick

One of the purposes of these site visits is to look for the formation of a Local Committee who will look after all applications for Merit, Excellence and Innovation Awards. The Committee will be chaired by a Governor grade with POA representatives also sitting on this committee. Any recommendations from the Local Committee will feed up to the National Staff Recognition Committee for consideration.

It is also important to stress that Staff Recognition comes in many forms and applications forms will be available in the near future on the IPS website. The policy document will also be available to view on the IPS website.

It is also envisaged that Staff Recognition/ Medal presentations will take place once a year in each location. It is also important to stress that the presentations of Long Service Medals and Merit Awards are totally voluntary. If any Staff member wishes to receive their award in private then that will be facilitated in each location. For further information on this policy please contact your Local Branch Committee.

National Officers of Prison Officers Association were represented on the night by the President Tony Power and Vice President Declan Mullally, both of whom received medals on the night, and Information Officer Paul Purcell.

After the formalities of speeches, presentations and photos all could settle in to enjoy the banter and the food provided.

The work of the staff recognition committee should be acknowledged and it is hoped by the committee to add Merit awards to future ceremonies.

THE INAUGURAL CORK PRISON COMMUNITY COACHING COUCH TO 5K

The inaugural Cork Prison Community Coaching Couch to 5K run took place on Tuesday 20th of November 2018. Over forty hardy souls toed the line on what was an ideal day for running and the event was officially launched by the Lord Mayor of Cork City Cllr. Mick Finn.

Prior to the off, Assistant Governor Peter O'Brien presented a cheque, for money raised, to the value of €1,000 to Head Teacher Edel Cunningham for the Dillon's Cross Project. The Dillon's Cross Project is an educational project located on the North side of Cork City which provides support and educational opportunities to female relatives of people in prison.

Race participants included Prison staff, PSEC staff, Teachers, Probation and Psychology staff, IASIO Staff, staff from the Trades department and prisoners who were either present or past participants of the Community Coaching Course.

The course comprised 11 laps of the interior of the Prison. First home,

after lapping everyone at least once, was Finbarr O' Dwyer (PSEC). Finbarr was followed home by Ger Moore (Cork Prison) in second place and Don Horan (Trades Department) in third, despite Don being sent out for a twelfth lap by (now retired) race marshall Mick Dooley.

The race, which was primarily for the prisoners participating in the Community Coaching Course, was a resounding success due to the buy-in from all prison staff and our multi-disciplinary colleagues. This participation, along with the presence of the Lord Mayor, provided a sense of occasion and a buzz throughout the prison. Special thanks must go to the Cork Business Houses Athletic Association (BHAA) who came into the prison and provided the finish line clock as well as looking after the entries and results.

It is our hope that this initiative, combining prison management, staff, services and the prisoners participating in the Community Coaching Course, will ensure that the race becomes an annual event in the Cork Prison calendar.

Ray said, "It's such an honour to be asked to be ambassador for this year's campaign. Organ donation is something that I feel very strongly about. Listening to people's stories down through the years about organ transplantation, dialysis and organ donation, sometimes heart-warming and at other times heartwrenching, I honestly believe that there is no better gift in life than the gift of organ donation".

"I have heard from grieving families about the solace they have got from donating the organs of someone they have loved knowing that other individuals and families have benefited. The news of a person receiving a transplant affects the families involved and it ripples through communities around Ireland."

"I have also heard how people's lives have been transformed through organ transplantation and I commend the donors who have made this possible. There are approximately 550 people in Ireland awaiting an organ transplant and hopefully these people's lives will be saved through organ transplantation. I would encourage everyone to discuss organ donation with their family members as I have done with mine. It doesn't have to be a long conversation, but it is such a vital and potentially lifesaving one. The legacy of organ donation by selfless deceased donor families is profound."

Chief Executive of the Irish Kidney Association, Mr. Mark Murphy said, "It's wonderful to have Ray D'Arcy, who enjoys household name recognition, lending his support once again to the Irish Kidney Association twenty-one years after first fronting the annual campaign. Ray has always demonstrated great empathy for people touched by organ failure. To have such a popular figure representing the Irish Kidney Association (IKA), a charity organisation of patients and carers, carries with it huge impetus to the work we have undertaken advocating and caring for our patients".

The IKA is the organisation charged with the promotion and distribution of the organ donor card in Ireland through Organ Donation and Transplant Ireland (ODTI), the organ procurement service of the HSE.

There are approximately 550 people in Ireland awaiting life-saving heart, lung, liver, kidney and pancreas transplants. Thanks to the gift of organ donation almost 4,000 transplanted people in Ireland are enjoying extended life.

The focus of Organ Donor Awareness Week is to remind individuals to talk to their families about their organ donation wishes and keep the reminders of their decision visible by carrying the organ **donor card** and permitting **Code 115** to be included on their **driver's license or downloading the 'digital organ donor card' APP to their smartphone.**

Organ Donor Awareness Week also serves as a fundraising exercise for the Irish Kidney Association. Throughout the Week (March 30th - April 6th 2019), the Association's volunteers will be out on the streets, and in shopping centres throughout the country, distributing organ donor cards while selling 'forgetme-not-flower' emblems, brooches, pens and shopping trolley discs. All proceeds go towards the Irish Kidney Association's aid for patients on dialysis and those patients fortunate enough to have received a kidney transplant. The Irish Kidney Association's charitable activities include the provision of a 13-double bedroom, free accommodation facility for patients and their families in the grounds of Beaumont Hospital and plans for the development of a similar facility at Cork University Hospital are underway. Patients, many who would otherwise be unable to travel and take family holidays due to the constraints of dialysis treatment, can avail of IKA holiday centres located in Tramore, Killarney and Tralee. The Irish Kidney Association also provides patient advocacy, advice, counselling, financial aid and rehabilitative, health promotion through sport and the provision of kidney patient information and education through its head office in Dublin and its 25-branch network of volunteers nationwide.

Information fact files, which accompany the free organ donor cards, are obtainable from the Irish Kidney Association and are available nationwide from pharmacies, GP surgeries and post offices.

RAISE THE ROOF CORK 11th March 2019

Trade unions and community groups came out in force in horrendous weather conditions at a rally outside Cork City Hall demanding radical action on the State's housing crisis. Over 1,000 people marched from City Hall to Connolly Hall for the rally.

The rally coincided with a motion being initiated at Cork City Council by Lord Mayor Cllr Mick Finn, which demands urgent action to address housing problems nationally and locally. It calls for significant investment in public housing construction through local authorities, action on evictions and rent certainty for tenants and a legal right to housing.

Barry Murphy, spokesman for Cork Raise the Roof, said there were record levels of homelessness, record numbers on housing waiting lists and huge levels of insecurity in the rental sector.

"The protest rally is a chance for the people of Cork to show their dissatisfaction with failed Government policy on housing and to demand action on the single greatest problem facing our society today."

A Raise the Roof rally in Dublin last October in support of an Opposition Dáil motion on housing saw an estimated 15,000 people gather to call for greater State involvement in the provision of housing.

Inspire Workplaces 24/7 counselling service is available to all Irish Prison Staff (formerly Carecall). This is an important enhancement of the Irish Prison Service EAP, Prison staff still have full access to local SSO's and centrally based EAO's and are encouraged to continue to engage with local SSO's and EAO's who are available to provide advice and support on a range of issues and may well suggest a referral to Inspire Workplaces where more focused emotional support is considered to be helpful. The EAP can be contacted at 043-333 5316 or at eapsupport@ irishprisons.ie

The Counselling Service is a confidential employee support service designed to support employees resolve personal or work related concerns, through telephone and on-line support and telephone or face to face counselling (up to 6 sessions) free of charge to all serving Prison staff.

Attendance at counselling sessions must be undertaken when off duty. Appointments are available in the evenings and at week-ends. However, once counselling sessions are scheduled for you, any cancellations within 24 hours or non-attendances for whatever reason will be included in the 6 sessions allowed. Should you cancel your appointment within 24 hours or indeed not turn up for one of your scheduled sessions this incurs a financial cost but more importantly your benefit from the course of 6 sessions provided is reduced as a consequence. You are strongly encouraged to attend all scheduled sessions and when it is necessary, to provide more than 24 hours' notice to your counsellor in the event you need to cancel or reschedule your appointment

In addition to the counselling service proved by Inspire Workplaces, prison staff also have access to extensive online support provided by Inspire Workplaces via their website, www.inspirewellbeing.org.

When you are browsing the website, Inspire Workplaces have a menu of options on the top right hand corner, one of which is a login option. The log in details for this service, for prison staff are:

There are 3 options to choose from on the left of the home page:

- 1. On-line tests This section includes optional self-report tests on Stress and Alcohol consumption and may well provide an indication that further support is warranted.
- Self-help library This sections includes advice and support on topics including amongst others anger, anxiety, 2. bereavement, my family, sleep, stress, and my work. Under each of these topics there is a number of subcategories. For example, if you click on My Family, you are directed to advice on 'empty nest syndrome' and 'single parenthood' and the advice and guidelines contained in these sections are certainly well worth a look.
- Useful reports this section lists reports on key topics like Mindfulness and Mental Health and Work and also 3. includes reports from the World Health Organisation report.


The website also has a section to support students, either yourself if you are studying or one of your children.


