## **COVID-19 UPDATE**

on weeks where prisoners are not availing of physical visits. Furthermore, prisoners will not be permitted to avail of a virtual visit on the same week as they receive a physical visit. **Resourcing of visits** 

Physical visits and virtual visits will take place on specific days which may vary from location to location. However, physical and virtual visits will not run concurrently on the same day.

All tasks associated with physical visits will be resourced through the usual dedicated resources.

In order to ensure the greatest degree of infection control, and to help ensure the good order and security of each prison, each unit within a prison will be assigned a specific day/half day for physical visits to occur, depending on numbers required.

#### **Impact on Regimes**

The provisions of each prisons Regime management plans must be amended to facilitate physical visits on specific days. Such changes will maintain the focus on ensuring a safe working environment for all staff and maximising out of cell time of prisoners not impacted by physical visits.

Furthermore, all tasks developed in response to COVID19 will continue to be performed subject to Public Health advice and the decision of IPS management. Any impact arising from a change in COVID 19 related tasks will be discussed between the parties. All Prisons must identify and provide a list of all COVID19 related posts.

#### Screening and searching of visitors

All visitors will be subject to temperature screening and questionnaire. Visitor screening will take place in visitor waiting room with standard screening taking place at screening/search area in line with the relevant SOP.

#### **Cash and prisoner property**

There will be no cash handling exchanged from visitors and new EFT/An Post arrangements for any lodgements to prisoner accounts. In addition, there will be no exchange of prisoner property in stage 1 of the easing of restrictions. This will remain under review as the easing of restrictions progress through various stages. Any resumption of Property exchange is dependent on individual Prison Governors written confirmation that they have a process in place to ensure full compliance with the Prisoner Property Policy including volumetric control.

On 24<sup>th</sup> July the POA wrote to the Director General regarding the decision made by the Irish Prison Service to swab test all visitors to Prisoners. Whilst the POA fully support any initiatives that assist in the reduction/elimination of

illegal substances in our prisons, we raised a number of concerns arising from this decision which included:

- > No formal training has been delivered and signed off on
- No time and study motion had taken place delays are an obvious concern when a return to full visits occurs
- Use of the machine appears to be cumbersome and at variance with other similar devices at Airports
- No intelligence based approach has been considered by IPS
- In the event of an unreasonable delay with the swabbing machine re-setting, visitors will not be allowed enter the Prison which could be a serious cause of conflict
- Breach of Section 12.2 of Agreed Report 5/1997

It was again obvious that ongoing consultative deficits with management were continuing to occur with a complete lack of understanding of the employment relationship appearing to prevail. This was particularly obvious with the approach taken by IPS to Divisional unlock. The POA expressed serious concerns in relation to the impact these decisions could have on our ability to restrict the spread of the virus in circumstances where greater movement and interaction of prisoners were allowed. No clear focus was evident on issues such as social distancing compliance among the prisoner population.

However, in September the Director General took the opportunity to write to all prison Governors and warn them that they should "ensure full compliance with all Covid-19 policies, Standard Operating Procedures and/or guidelines over the coming months. The DG went on to direct that "Any breach of policy, SOP or guideline must be treated seriously and where appropriate disciplinary actions must be commenced under the Code of Discipline as per the new Addendum". Arising from the issuing of this diktat the Union wrote to the DG on Friday 18th September where we highlighted the conflicting approach taken by her office when managers failed to adhere to Public Health advice to that taken when basic grade staff (frontline workers) had minor infringements. An urgent meeting was sought with her and this took place on Thursday 15th October. At this engagement the Director General informed the Union that she had recently advised all Governors that should any further outbreaks occur where large numbers had to be sent off duty due to contacting tracing advice, the local Governor would also be held accountable in tandem with individual frontline staff. The POA will await the outcome that this decision will have, but we won't be holding our breath based on previous experiences!

## Why do IPS continue to snatch defeat from the jaws of victory – Covid 19 update

"Any breach of policy, SOP or guideline must be treated seriously and where appropriate disciplinary actions must be commenced under the Code of Discipline as per the new Addendum" – Director General Caron McCaffrey (email to all Governors – Sept 2020)

In our previous article members were brought up to date on all matters relating to Covid dating back to the POA's initial contact with the IPS on 24<sup>th</sup> January 2020. Whilst a partnership approach was taken in the early weeks of the pandemic, it was clear to us that the IPS had decided to walk away from this well proven methodology during the summer period. This of course occurred at a time with the "R" rate was at its lowest and the country was enjoying a short reprieve from the ongoing crisis. There is no doubt on the part of the POA that the hard work done by our members in a radically changing and evolving environment contributed in no small way to the success in keeping our prisons Covid free for such a prolonged period of time.

We cautioned previously that the pace at which the IPS wanted the unwinding of restrictions to be lifted was unreasonable and potentially unsafe. This position was articulated by us at our first meeting with the new Minister for Justice on Tuesday 11<sup>th</sup> of August where the ongoing management of Covid was a specific item on the agenda for the Union.

As the end of the summer approached and following a number of engagements with management, a 25 point document was issued by IPS in relation to specific procedures to follow on the recommencement of physical visits. New temperature check equipment was installed, and health check questions would be asked of visitors in the waiting room with face masks to be worn at all times.

Furthermore a "Reintroduction of Physical Visits in the Irish Prison Service" document was issued to all Governors. This document was devised following extensive engagements between the IPS and the Prison Officers Association and represented an overarching process and principals arrangement under which the decision to reinstate physical visits would be operationalised. The main areas identified can be summarised as follows:

#### **Regime Management Plans**

The parties note that the application of Regime Management Plans in order to ensure safe working environment for staff and maximising access to prisoner regimes is the established position of the IPS. Accordingly, any measures/tasks to be implemented in either the easing of physical visiting restrictions, the lifting of any other restrictions related to COVID 19 or any measures to enable greater out of cell time/prisoner access to regimes, will only be implemented through the utilisiation of RMPs and resultant safe systems of work.

#### **Process of engagement**

It is reaffirmed that the parties will continue to engage on all relevant response measures related to COVID 19 or the unwinding of restrictions related to same. It is agreed that the appropriate forum for such engagement is through national engagement between the parties in the first instance.

The parties are also agreed that any changes in the roadmap outlined in this document, in response to Public health advice or operational reasons will be subject to discussions between the parties.

#### **Visit details**

Phase 1 – Return of Physical Family Visits (20 July 2020) All prisoners will be entitled to receive <u>one physical family</u> <u>visit per fortnight</u>, of not more than 15 minutes duration. In order to prevent the potential spread of infection all visits will be behind Perspex screens and visitors will be required to wear a face covering at all times.

No physical contact between prisoners and family members will be permitted.

#### Phase 2 - Monday 17th August 2020

All prisoners will be entitled to receive **<u>one physical family</u>** <u>visit per fortnight</u>, of not more than 15 minutes duration. Physical visits during this phase will be <u>limited to two</u> <u>people</u> of which one visitor may be a child.

Visitors will continue to be required to wear a face covering No physical contact between prisoners and family members will be permitted.

#### **Composition of visiting options for prisoners**

The IPS will continue to offer virtual visits to all prisoners

## Pay Update

On Thursday 30th July 2020, the Union received correspondence from the Secretary of the ICTU Public Services Committee regarding their recent meeting with the Minister for Public Expenditure and Reform and a number of his Officials. This correspondence outlined that there was a wide ranging and constructive discussion between the parties and that the Minister re-affirmed the intention to honour the terms of the Public Service Stability Agreement, including the final payment of 2% due on the 1st October 2020.

Both sides agreed that there should be engagement in early September to explore the potential for a successor public service agreement. In essence, the meeting consisted of both sides setting out the broad context for talks on a possible future agreement.

It was agreed that a further meeting would take place in early September and it should be possible to better judge the prospects for such an agreement and the issues and difficulties that are likely to arise, following that meeting.

The final pay measure under the terms of the Public Service Stability Agreement 2018 – 2020, a 2% pay adjustment was implemented with effect from Thursday 1st October 2020.

On Friday 23rd October 2020, there was a meeting of the ICTU Public Services Committee where the Chairperson advised unions that there was no basis at that time for a negotiation with the Government on a new public service pay agreement. The Chairperson expressed disappointment at the lack of progress made in recent months with the Department of Public Expenditure and Reform despite discussions with the Minister in July. The Chairperson further outlined that the basis of negotiations for a new public service agreement would need to address specific austerity measures, include an acceptable approach to pay, and provide a clear path to resolving particular long-standing issues within public service grades, groups and categories, ensuring an ultimate resolution in each case. He said these priorities had been outlined to DPER officials as the basic requirements of any negotiation.

There was a follow up ICTU Public Services Committee meeting held on Tuesday 24th November 2020, where the Chairperson outlined that following recent engagement with the Department of Public Expenditure, the Officer Board were expecting an invitation to discussions on a successor to the Public Service Stability 2018 – 2020.

The constituent unions of the ICTU Public Services Committee having listened to the briefing given by the Chairperson decided to accept any such invitation should it be without pre-conditions.

At the time of this edition of the magazine going to print there was a follow up ICTU Public Service Committee meeting scheduled to take place on Thursday 3rd December 2020, for the constituent unions to be updated on any developments.


# **STEPHEN DELANEY**

#### 2/02/1939 to 22/09/2020

The Irish Prison Service lost one of its best on September 22nd 2020. Stephen Delaney joined the Irish Prison Service in 1958, started in Mountjoy and worked throughout his career in St. Patricks, Limerick, Portlaoise, Shelton Abbey and Wheatfield. Stephen retired in 1992.

Stephen was diagnosed with Pancreatic Cancer in June 2020. Just as you would expect he fought hard against all the odds and he kept going and had a positive outlook even throughout his chemotherapy treatment.

Stephen's Father, Joseph Delaney, was in the Prison service prior to the foundation of the state. He travelled to England to become an English Constable so that he could return to Ireland and join the Irish Prison Service as the then British Government didn't trust the Irish to work as prison officers and look after Irish prisoners. Stephen was married to Catherine (Kitty), who passed away in 2013 and is survived by his 3 sons and 1 Daughter, Stephen Jnr, Tommy, Joseph and Marguerite. Stephen Jnr



and Tommy both also joined the Prison Service and both also became National Officers of the POA, President & General Treasurer.

Throughout his career in the Prison Service he was always highly regarded as Chief Officer Class 1, President & General Secretary of the POA. Stephen was proposed by the staff for POA headquarters while he was a Chief Officer. He served as President and General Secretary of the POA. He was also one of the founding members of the Medical Aid. During the 1998 Strike Stephen was the highest ranking officer to join the staff on the picket line. At the time he was promised from the Department of Justice that he would be Governor if he didn't go out on strike with the staff but for anyone of us that knew Stephen we know that he couldn't be bought.

When Stephen retired from the Prison Service in 1992 he joined and became President of the Association of Retired Prison Officers (ARPO). He held this post right up until his passing. He always loved representing staff and endeavouring to make conditions better for staff both serving and retired. Throughout his life Stephen spent 56 years representing staff from his first union job as Branch Secretary in St Patricks in 1963, following on as President & General Secretary of the POA and right up until June 2020 as President of ARPO.

Above and beyond all his many accomplishments in his work life the most important part of his life was his family. He was incredibly happy and proud of his family in every way, his wife, his children and his grandchildren meant everything to him and to anyone who knew Stephen or met him this was abundantly clear.

"When some fellers decide to retire nobody knows the difference".


For us however, your departure brings to mind Hemmingway.

Ray delved into the themes explored in the poetry of O'Ríordáin, themes not just of suffering and desire but, equally, those of contentment, fulfilment and ultimately happiness. The latter, explained Ray, is the great theme of Cnoic Mellerí. The poet's coming to terms with his catholic consciousness.


## **Colm Cronin Cork Prison Retirement**

## **DISCIPLINARY CODE**

# Civil Service Disciplinary Code and the Civil Service Under performance Policy COMES INTO EFFECT 1ST OCTOBER 2020

The Civil Service Disciplinary Code and the Civil Service Underperformance Policy has come into operation in the Irish Prison Service with effect from Thursday 1st October 2020.

From this date the Prison (Disciplinary Code for Officers) Rules 1996 will be revoked and replaced by the Civil Service Disciplinary Code to deal with disciplinary matters in the Irish Prison Service.

The Revised Civil Service Disciplinary Code was introduced into the Civil Service with effect from Thursday 1st September 2016. Circular 19/2016, sets out the arrangements for dealing with disciplinary matters in the Civil Service

The purpose of this Code is to set out the arrangements for dealing with disciplinary matters in the Civil Service. It is also to ensure that all civil servants are aware that if there is a failure to adhere to the required standards of conduct, work performance and attendance, the disciplinary procedures set out in Circular 19/2016 will apply.

Procedures will be initiated where a concern arises about the conduct, work performance, and/or attendance of a civil servant. They will provide a fair and efficient process for dealing with any such concern. This Code applies to all civil servants other than new entrants serving in a probationary capacity.

The Civil Service Management of Under Performance Policy was introduced into the Civil Service with effect from Sunday 1st January 2017. Circular 24/2016, sets out the arrangements for managing under performance in the Civil Service.

The Civil Service Management of Under Performance Policy applies to all civil servants except new entrants serving in a probationary capacity. The purpose of this



Policy is to provide a clear framework to help managers to identify and deal with issues of Under Performance effectively in the Civil Service.

### Who needs platelets?

Children and adults with cancer or leukaemia need platelets after having chemotherapy and radiation treatment.

Platelets are also needed by:

- New born babies
- Bone Marrow and organ transplant patients
- Burns victims and patients undergoing extensive surgery

#### How are platelets collected?

The donation process is quite simple and takes from 60 to 90 minutes depending on the procedure. Your blood is processed through a cell separator where it is separated into the different components. The platelets are removed and collected in a bag, while the remaining components are returned to your body.

#### To be a platelet donor, you must:

- Be between 18 and 59 years of age (before 60th Birthday)
- Weigh 60 kg or more (9 stone 7 lbs.)
- All blood groups are needed O, A, B and AB

# Darragh's memory cherished by Mizen to Malin Cycle Event



He was just 28 years old when he died suddenly but, in his short life, Prison Officer Darragh Kenny had already made many friends on this earth. A keen sports participant, Darragh played soccer for St John's Athletic FC in Lecarrow, county Roscommon and in his childhood years he played Gaelic Football and Hurling for St Dominics GAA club in county Roscommon. Having joined the Irish Prison Service,

he made an immediate impact with colleagues and friends where he worked in Mountjoy Prison in Dublin. It was there on the 15<sup>th</sup> day of January in 2013 that he died suddenly through cardiac arrest.

Darragh was a native of Gort, Lecarrow, in county Roscommon. The son of Liam and Fidelma, he was a popular young man who enjoyed his work and his sports. In the aftermath of his death, as friends and family shared their grief, it was decided that his life should be commemorated and an annual event was organised in his memory. People from all over the country have taken part in a series of memorial cycles over the last number of years with over 90,000 Euro already raised and the 2020 event has already brought in over 11,000 euro - albeit in a different format.

Todate, funds raised by the annual cycle have been donated to Croí, the Heart & Stroke Charity, in the fight against heart disease and stroke. Funds have helped Croí provide support



services and free accommodation in the Croí Courtyard Apartments for the families of those receiving heart or stroke care at Galway University Hospitals, with a plaque in Darragh's memory proudly displayed on the wall outside one of the Courtyard Apartments. This year a group of cyclists, who cycle with the Lecarrow Lazers Cycling club, decided to complete a personal goal and cycle from Mizen to Malin in mid-September. The Lecarrow Lazers cycling club normally

runs a number of Charity Sportives and is involved every year with the organisation of the Darragh Kenny Memorial Cycle. Due to COVID-19 restrictions this year, all of these Charity Sportives have had to be cancelled. With this in mind the group of cyclists decided that they would use their cycle to raise some much, needed funds for charity. They chose Croí because of the clubs close link with the Kenny family and the Darragh Kenny Memorial cycle and also the Lough Ree Access for all boat based in Ballyleague and Lanesboro which will be used to transport wheelchair users from all over the country around the Roscommon lake and further afield.

The Lough Ree Access for All Boat is the only vessel in the Republic of Ireland and Britain which is licenced to carry up to 8 wheelchair users on board on the waterways. Its unique design makes it accessible to all people with disability and it is supported by members of the Irish Wheelchair Association and Independent living Ireland. For info, email: <u>loughreeaccessforall@gmail.com</u>. Croi have recently established a new free community support service across Ireland, Heartlink West. Funds raised from this cycle will support this dedicated helpline, led by Croi's highlyexperienced cardiac nurse specialists with considerable expertise in risk factor management and cardiovascular care. The cycle is being self-fundedby each of the cyclists and all money raised will go directly to these two deserving causes.

Due to the COVID-19 outbreak and current restrictions, the raising of funds for the Darragh Kenny Memorial fund had to be mainly through online and virtual events. A new series of social media pages were set up to keep the public up to date (search Darragh Kenny Memorial Fund) across Facebook, Twitter and Instagram, and donations can still be made online through the iDonate page. – <u>http://www.idonate.ie/</u> <u>DarraghKennyMemorialFund</u>

The fundraising in the streets may have been restricted but there was stopping the eleven people from the successful Lecarrow Lazers cycling club who set off on the mammoth journey from Mizen head to Malin head between September



16<sup>th</sup> and September 19<sup>th</sup>. The club embraced the challenge with even more enthusiasm than normal and even though their numbers were restricted they still wore the Darragh Kenny Memorial jersey with some pride from the very south of the island to the very top most northern point. The event was a really terrific success. The cyclists this year were John Dolan, Mary Lennon, David Ingram, Declan O'Rourke, John Brennan, Marie Brennan, Brian Duffy, Michael O'Connor, Noel Galvin, Wilker Costa and Padraig Hanley. The cyclists were supported by Brendan Donnelly as support driver.



## **CRIMINAL INJURIES**

Over the past number of months, the National Office of the Prison Officers Association has received numerous queries in relation to Criminal injuries and the Criminal Injuries Compensation Scheme. Resulting from this we have formulated the undermentioned questions and answer to guide our members who may have been injured and are submitting an application to the Criminal Injuries Compensation Tribunal.

Q1. What is the Criminal Injuries Compensation Tribunal and what do they do?

The Criminal Injuries Compensation Tribunal provides for the payment of ex-gratia compensation in respect of a personal injury inflicted on a prison officer. The injury must have been sustained on or after the 1st April 1986. The scheme is funded by the Department of Justice and Equality and administered by the Criminal Injuries Compensation Tribunal. The Tribunal currently consists of a Chair and six ordinary members. It administers two non-statutory schemes.

- > The Criminal Injuries Compensation Scheme.
- A Criminal Injuries Compensation Scheme for Prison Officers.
- Q2. Are there minimum requirements?

Yes.

- Applications must be in writing and made as soon as possible but not later than 3 months after the injury event.
- > The injury must have been criminally inflicted.
- The event must have been reported to An Garda Siochána and full cooperation given to the criminal investigation. Applicants must indicate if the incident is the subject of criminal proceedings.
- Applications must be supported by appropriate documents and receipts.
- Other limitations also apply as set out in the Scheme.

Q3. When must an application be made? Paragraph 21 of the General Scheme provides that an application must be made in writing as soon as possible after a crime of violence causing injury, including fatal injury, but in all cases not later than 3 months from the date of the event giving rise to the injury.

Q4. How do I report my Injury to the Criminal Injuries Compensation Tribunal? Contact the Criminal Injuries Compensation Tribunal by phone. You will be advised by the Secretary of the Tribunal to request a Tribunal application form via email. This application must be completed and returned to the tribunal within three months

Q5. When submitting my application do I need all supporting documentation?

**NO**, supporting documentation may take longer than 3 months to obtain. Complete as much of the application form as possible and return the form to the Criminal Injuries Compensation Tribunal. It is vital that your application is received by the Criminal Injuries Compensation Tribunal **not later than 3 months from the date of the event giving rise to the injury**.

Q6. What happens if a situation arises and my application form is not submitted within 3 months after the date of injury.

Under the terms of the Scheme applications for

compensation should be made as soon as possible and must be made within 3 months from the date of the incident causing the injury. However, the Tribunal has discretion to admit a late application "in circumstances determined by the Tribunal to justify exceptional treatment".

## Q7. Will I get paid my allowances when I am out Sick as a result of an OID

Yes. As per the Director of Staff and Corporate Services instruction dated 13<sup>th</sup> September 2016 regarding Occupational Injury or Disease (OID) advised that allowances and additional hours payments **will not be suspended** pending a decision of an OID application.

It is important that Staff are aware that should their absence subsequently be deemed not to qualify as an IOD absence, any such allowances or monies which were overpaid will be recouped as per Circular 07/2018 - Recovery of Salary, Allowances, and Expenses Overpayment s made to Staff Members /Former Staff Members /Pensioners.

### Occupational Injury or Disease - Checklist

- 1. Report incident to Governor and / or Gardai.
- 2. Ensure prisoner(s) are put on report (P19).
- 3. Seek medical treatment for injuries from G.P. and / or Hospital on day of injury.
- 4. Fill out NIRF (National Incident Report Form) immediately if possible or on return to work.
- Submit email to HR Governor requestion to have your injury recognised as an injury on duty. If you wish you can request that your allowances and annualised hours continue to be paid pending the decision on the OID application.
- Contact Criminal Injuries Tribunal via email reporting the incident and request a criminal injuries application form.
- Criminal injuries application form must be completed and returned to the Criminal Injuries Tribunal within three months of injury.
- 8. Obtain copies of witness statements.
- 9. Obtain copy of P.19(s).
- 10.Obtain medical reports from G.P and/or Hospital.
- 11.Submit medical reports to Criminal Injuries Tribunal.

Several members joined the Royal Navy. A number of staff remained in Headquarters Irish Command also.

A number of prison staff enlisted in the Military Provost Corps. The Military Provost Corps provided operational support, technical advice and expertise in handling prisoners of war. In reality they just swapped the jailers uniform for an army uniform. They were retained serving at the Prisoner of War camp in Oldcastle, Co. Meath. The old Workhouse in Oldcastle was commandeered by the army, refurbished and brought to a sufficient standard for use as a Prisoner of war Camp. Governor Major Robert Johnson V.C. was the Governor in charge.

Major Johnson V.C. joined the General Prisons Board in 1911. He was P.O.W. Camp Commandant 1914

A. Hade Ordinary Warder Maryborough Gaol, Royal Irish Rifles was listed as being a Prisoner of War.

#### **Governor Major Robert Johnson V.C.**

Robert Johnson was born on the 13th of August 1872 in the townland of Cloughore between Ballyshannon and Belleek in south Donegal. Educated in the Isle of Man, Robert Johnson played international rugby for Ireland, being capped twice the first time against England in 1893. Robert Johnson was also a member of the British Lions squad which toured South Africa in 1896.

When the Lions tour ended, together with Tom Crean Johnston stayed on in South Africa. When the First Boer War started in 1899, again with Tom Crean, Robert Johnson enlisted in the Imperial Light Horse. In October of 1899 in the Battle of Elandslaagte, while still a Captain, Johnston particularly distinguished himself winning his V.C. Captain Charles Herbert Mullins also won a V.C in the same action. Their joint citation reads:

On the 21st October, 1899, at Elandslaagte, at a most critical moment, the advance being momentarily checked by a very severe fire at point blank range, these two Officers very gallantly rushed forward under this heavy fire and rallied the men, thus enabling the flanking movement, which decided the day, to be carried out.[8]

In 1900 Johnson was seriously wounded . Nursed back to health by Tom Crean , he returned to London in early 1901 . On the 25th July 1901 during an investiture in Buckingham Palace both Johnson and Mullins received their V.C.

Robert Johnson returned to Ireland in 1911 and joined the General Prisons Board for Ireland. He was appointed Commandant of the Prisoner of War camp at Oldcastle, Co Meath in 1914. The Workhouse in Oldcastle was built in 1842 and at the outbreak of the war in 1914 was empty. Fortified and made ready from 1914 until June of 1918 it housed up to 600 men of German or Austro-Hungarian origin.

Robert Johnston transferred to His Majesty's Convict Prison Maryborough in 1915 and then returned to Oldcastle Prisoner of War Camp in 1916. He remained in charge of the camp at Oldcastle until June of 1918 when all internees were transferred to the Isle of Man. It was deemed by the British




Government at that time to be a safer location to house that amount of prisoners due to the political situation in Ireland.

Major Robert Johnson V.C. , retired

Prison Governor , settled in Kilkenny where he was appointed Resident Magistrate. He died on the 24thMarch 1950 .







# **Inspire Workplaces - On line Resources**

Inspire Workplaces 24/7 counselling service is available to all Irish Prison Staff (formerly Carecall). This is an important enhancement of the Irish Prison Service EAP, Prison staff still have full access to local SSO's and centrally based EAO's and are encouraged to continue to engage with local SSO's and EAO's who are available to provide advice and support on a range of issues and may well suggest a referral to Inspire Workplaces where more focused emotional support is considered to be helpful. The EAP can be contacted at 043-333 5316 or at eapsupport@ irishprisons.ie

The Counselling Service is a confidential employee support service designed to support employees resolve personal or work related concerns, through telephone and on-line support and telephone or face to face counselling (up to 6 sessions) free of charge to all serving Prison staff.

Attendance at counselling sessions must be undertaken when off duty. Appointments are available in the evenings and at week-ends. However, once counselling sessions are scheduled for you, any cancellations within 24 hours or non-attendances for whatever reason will be included in the 6 sessions allowed. Should you cancel your appointment within 24 hours or indeed not turn up for one of your scheduled sessions this incurs a financial cost but more importantly your benefit from the course of 6 sessions provided is reduced as a consequence. You are strongly encouraged to attend all scheduled sessions and when it is necessary, to provide more than 24 hours' notice to your counsellor in the event you need to cancel or reschedule your appointment

In addition to the counselling service proved by Inspire Workplaces, prison staff also have access to extensive online support provided by Inspire Workplaces via their website, www.inspirewellbeing.org.

When you are browsing the website, Inspire Workplaces have a menu of options on the top right hand corner, one of which is a login option. The log in details for this service, for prison staff are:

There are 3 options to choose from on the left of the home page:

- 1. On-line tests This section includes optional self-report tests on Stress and Alcohol consumption and may well provide an indication that further support is warranted.
- 2. Self-help library This sections includes advice and support on topics including amongst others anger, anxiety, bereavement, my family, sleep, stress, and my work. Under each of these topics there is a number of sub-categories. For example, if you click on My Family, you are directed to advice on 'empty nest syndrome' and 'single parenthood' and the advice and guidelines contained in these sections are certainly well worth a look.
- 3. Useful reports this section lists reports on key topics like Mindfulness and Mental Health and Work and also includes reports from the World Health Organisation report.

The website also has a section to support students, either yourself if you are studying or one of your children.
